# **BRIEF BIO:**

A dedicated and experienced administrator, I have a proven record of success guiding transformative change in a large academic operation. In five years as Dean of the Dodge Family College of Arts and Sciences (DFCAS), and one year as Interim Dean, I have worked with my team to move from a major inherited financial debt (-\$12M) to excellent fiscal health; secured the largest gift in OU history to name the college, an additional \$16M gift to found a new quantum research center, and secured two significant department naming gifts. We have implemented a new strategic plan, Pathways to Excellence; founded a new School of Biological Sciences and will establish a new School of Population Health and Human Performance; have created new endowed undergraduate scholarship cohorts for 450-500 students and built bridge programs to facilitate access for underserved students. I have provided stability and clear direction during a period of multiple transitions in OU's executive leadership. My vision emphasizes both the research and teaching missions; building graduate education and ensuring undergraduate excellence; championing access and inclusive excellence; and guaranteeing long-term success and access through endowment funding. A historian of American thought and the American West, I have worked in private liberal arts college and large public universities since 1990. I came to OU as the Merrick Chair in 2011 and was the inaugural recipient of OU's highest faculty honor (David Boren Professor) in 2016. An active scholar-teacher, I recently served as president of my primary scholarly organization (Western History Association). A native Londoner, I am a dual citizen of the USA and UK.

# Administrative Scope and Scale:

Work with a team of four Associate Deans, four Executive Directors, and 200 staff to serve the needs of OU's oldest and largest college: over 600 full-time faculty, 10,000 majors (7,500 undergraduate, 2,500 graduate), 28 departments and programs, and a dozen research centers, institutes, and state surveys on two campuses (Norman and Tulsa), + ROTC Army, Air Force, and Navy branches (joined the College in July 2023).

# **Fiscal Management:**

• Oversee a \$100M+ budget. DFCAS consistently generates \$30M+ in annual revenue over and above operating expenses to help fund OU's other operations.

• Swift restoration of fiscal health, including a balanced budget, 3 years after taking on a \$12M combined debt and deficit in July 2017.

College produces 54% of all credit hours (including 75% of Gen Ed) at OU with 42% of the academic budget—lowest cost per credit hour, and best faculty and staff FTE to credit hour production ratios at OU. OU's most cost-efficient degree programs are in DFCAS.
Successful reorganization of college staffing structures during presidential transition,

resulting in next to zero layoffs during a period of major RIFs at OU.
